**Reduce the environmental impact of the company's activities and its products** by adopting the latest techniques and technologies and using materials with a lower environmental impact.

**Actively cooperate** with local research organisations, universities and associations to pursue the ecological transition and support innovative projects and initiatives in favour of environmental protection.
